Meadows at Yaphank guaranteed state funds



Meadows at Yaphank will get at least \$1 million from New York State

Mega mixed-use project assured \$1M, but eyes \$2M through LI council

A \$51.4 million Yaphank mega project is set to nab up to \$2 million in state funds.

Known as the Meadows at Yaphank, the 850-unit, mixed-use development nestled between the Long Island Expressway and the William Floyd Parkway was recently added to the Long Island Regional Economic Development Council's list of 2013 priority projects.

While 10 developments could re-

ceive funds between \$500,000 and \$3 million if the Long Island council is deemed to have one of the five best plans in the state for driving economic development, the Meadows at Yaphank is one of only two projects guaranteed to receive state funds regardless of whether the region claims one of the top prizes of \$25 million each.

Should the Long Island council land the coveted \$25 million, the Meadows at Yaphank developer, AVR Realty Co. of Yonkers, will receive \$2 million for the development. If it only takes home a \$5 million consolation prize, the Meadows at Yaphank and the highly publicized Wyandanch Rising projects
